### **Matters Requiring Action**

#### **1. Declaration of Performance:**

- **Declaration of Performance (DoP) Reference Number:** The unique reference number for the Declaration of Performance (DoP) is not stated or is unclear. Please ensure that the DoP number is clearly identified and prefixed with "DoP Number".
- **Declared Performances:** The declared performances in your DoP are not exactly aligned with Table ZA.1 of BS EN 1154:1997. To ensure compliance, we recommend that you comprehensively list all the declared performances specified in the standard. Where a performance is not declared, the term "No Performance Determined (NPD)" should be used.

Upon review, I have listed some of the discrepancies identified in your declared performances below:

- 5.2.3: Closing moment is missing.
- 5.2.4: Opening moment is missing.
- 5.2.5: Efficiency is missing.
- 5.2.6 Closing time is missing.
- 5.2.7: Angle of operation is missing.
- 5.2.8: Overload performance is missing.
- 5.2.10 Fluid leakage is missing.
- 5.2.11: Damage is missing.

This feedback is intended as a guide. Kindly ensure you thoroughly review the standard yourself to confirm compliance and address any additional requirements specified in Table ZA.1 of BS EN 1154:1997 when drafting your DoP to ensure compliance with the standard.

- **Declaration (Regulation 305/2011 Annex III):** Ensure that your declaration is written in compliance with the standard. The wording of the declaration of the DoP is not in accordance with the model given in Annex III of CPR 305-2011. It should be as follows: "The performance of the product identified above is in conformity with the set of declared performance(s). This Declaration of Performance is issued, in accordance with Regulation (EU) No 305/2011 [as it has effect in the United Kingdom in respect of Great Britain (the inclusion of these words is only applicable if your Declaration of Performance (DoP) is for UKCA marking.)], under the sole responsibility of the manufacturer identified above". I will attach a copy of Annex III of CPR 305-2011 for your reference.
